The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/5/2020, at approximately 2031 hours, I responded to Causeway Bl. and Falkenburg Rd S. Riverview, FL. 33578 to assist Deputy Fargo(ABN:257830) with a traffic crash(89442234). Deputy Fargo observed indicators of impairment from the defendant who was the driver of the vehicle at fault. The amount of damage from the traffic crash was approximately, \$8,000.00. When I arrived on scene, I observed the defendant to have indicators of impairment. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment.
