The victim and defendant have been in a significant and intimate dating relationship for approximately 3 years and have lived together in the past as a family. During an argument the defendant punched the victim in the head and face two times, slapped him in the face two times, and kicked him in the face one time with a bare left foot. The victim sustained a small circular shaped scratch to the center of his forehead, a scratch (approx. 2") across his right cheek, and a bloody abrasion to the upper right back of his head. The victim's shirt was also ripped and torn by the defendant.
