The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a silver 2010 Nissan Altima, 4 door, Florida tag JCIF72. The defendant drove in a manner in which she stopped beyond the painted white stop line at two red lights, drifted in the travel lane, drifted onto and over painted lane markers numerous times, and had difficulty maintaining a consistent speed as the speeds fluctuated up and down unnecessarily. The defendant drove at excessive speeds that was visually estimated and patrol car paced (unit 5055) at 70+ MPH in a properly posted 50 MPH speed limit. A traffic stop was conducted in order to check on the driver's condition to determine if she were sick, tired, distracted, or impaired. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, and her speech was slurred. The defendant wore a paper bar admissions band on her right wrist. The defendant stated she drank one beer tonight. The defendant was unsteady exiting the vehicle, her gait was unsteady, and she swayed noticeably while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances was arrested for DUI. The defendant provided breath samples of .179% BrAC and .169% BrAC. During a search of the defendant's purse, incident to arrest, a medium size jewelry bag containing a white powdery substance was located within a zippered compartment of the purse. The white powdery substance was field tested in CBT parking lot with a positive test result for cocaine (1 gram). The defendant was positively identified by her Florida DL.
