Probable Cause

On September 15th, 2021 at approximately 8:18 PM I was dispatched to a single vehicle crash that occurred on Interstate 95 (State Road 9) northbound south of Woolbright Road. The vehicle was reported all over the road and collided with a sign. After colliding with the sign the vehicle continued off

the roadway and turned over onto its left side. The vehicle came to final rest in the ditch. On my arrival I observed a white female later identified by her Florida Driver's License as AMANDA KAY POWELL (P400011798660) being carried by a Good Samaritan. The Good Samaritan placed Ms. Powell on the shoulder and I requested Emergency Medical Services to evaluate Ms. Powell. While looking at Ms. Powell I observed glassy eyes. At the scene, a witness by the name of Lillianne Theus told me the driver (Ms. Powell) was all over the road swerving lane to lane and almost collided with several vehicles. I obtained a Witness Statement from Lillianne Theus. I asked Ms. Powell if she can advise me on what happened on the crash and Ms. Powell seemed to be crying and emotional. After being medically assessed, the paramedics transported Ms. Powell to Bethesda Hospital. During my crash investigation I observed a tire marks from the outside lane into the grassy shoulder a Mile Marker Sign that was damaged and the vehicle at final rest on its left Driver's side.

When I arrived at the Hospital, Dr. Garrett advised that Ms. Powell had a blood alcohol level of .287. Dr. Garrett also advised me that Ms. Powell admitted to taking Xanax earlier during the day. I arrived at the hospital and made contact with Ms. Powell. I introduced myself and told Ms. Powell I was investigating the crash and Ms. Powell advised she was on the phone with her attorney and did not want to answer any questions. I advised Ms. Powell and her attorney that I was investigating the crash and both declined to answer any questions. I concluded my crash investigation and started my DUI investigation based on Witnesses providing a driving pattern and based on what Dr. Garret advised about Ms. Powell's blood alcohol content. Ms. Powell and her attorney chose to remain silent. I asked Ms. Powell if she would like to perform Standard Field Sobriety Exercises and still Ms. Powell and her attorney remained silent. I advised Ms. Powell of her Taylor Warning and she remained silent. I then arrested Ms. Powell and transported Ms. Powell to the Palm Beach County Jail.

I arrived at the BAT at 11:30 PM and conducted a 30 minute observation. At no point in time did Amanda Kay Powell regurgitate or take anything by mouth. Ms. Powell was taken into the room and asked if she was willing to provide a sample of her breath to determine the alcohol content of her breath. Ms. Powell continuously requested to speak to an attorney and would not provide a definitive answer. Ms. Powell was indecisive and continuously asked for legal advise after the request. I made Ms. Powell aware that it would be a refusal if Ms. Powell did not answer and Ms. Powell again did not provide a response. I read her Miranda rights and she stated she understood. After reading Miranda, Ms. Powell admitted to having one Whiskey drink earlier during the day with coworker. Ms. Powell also advised she took Xanax around 1PM and Adderall around 3PM.

Ms. Powell was then booked in the Palm Beach County Jail.

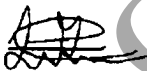
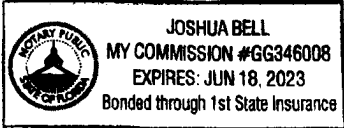
