Upon making contact with the defendant, she displayed multiple signs of impairment, including: slurred speech, a distinct odor of an alcoholic beverage on her breath, bloodshot/glassy eyes, conflicting statements about where she was coming from, and fumbling with her documents. The defendant exhibited several clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .122/.117.
