The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On the above listed date, time, and location I responded to assist Dep. Nagen (ABN:257646). Dep. Nagen observed a white Honda Civic bearing FL LIWJ18 (Vin: 19XFC2F83KE026273) failing to maintain their lane on Lakewood Dr. S / Brandon Main St. Dep. Nagen conduct a traffic stop on this vehicle and made contact with the driver. Dep. Nagen observed signs of impairment to be bloodshot glassy eyes, and the odor of an alcoholic beverage emitting from her breath (see supplement). Upon making contact with the defendant, I immediately observed signs of impairment to include, she had bloodshot glassy eyes, unsteady on her feet exiting the vehicle, and the odor of an alcoholic beverage on her breath. Post Miranda, Amber Farnner admitted to consuming two Cigar city draft beers. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises the defendant showed signs of impairment and was placed under arrest for DUI. I read to the defendant her Implied Consent Warnings in room CB-01, which she refused to provide a lawful sample of her breath. The defendant was identified via Florida Driver's License.
