The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did  
 On the above listed date and time at the above listed location, Deputy Brannum # 254966 was conducting a crash investigation (See case #21-148622 DHSMV #89445337). Deputy DiLascio #256642 was at the scene assisting Deputy Brannum with the crash investigation. Upon making contact with the defendant, Deputy DiLascio observed signs of impairment. Upon my arrival, I observed multiple signs of impairment. I informed the defendant the crash investigation was done and that I was going to conduct a criminal DUI investigation. I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs) which the defendant refused to perform. Based on the totality of the circumstances, the defendant was placed under arrest for DUI. Deputy Brannum advised me the total damage was approximately \$8000 dollars. Deputy Baker #214083 who was not working at the time, was the first person at the scene and observed the defendant behind the wheel. Upon arrival at Central Breath Testing, the defendant refused to provide two lawful breath samples to determine her breath alcohol content (BrAC). I read Implied Consent to the defendant in room #1 of Central Breath Testing, she understood and replied "I'm not blowing". The defendant received a DUI citation #A3BNS5E which reflects the DUI charge. The defendant was identified via her Florida Driver's License.
