Amber Nicole Potter W/F DOB 9/27/1994 was arrested for Possession of Schedule II Drug Pursuant to F.S.S. 893.13(6) (a), Possession of Marijuana Under 20 Grams Pursuant to F.S.S. 893.13(6) (b), and Operating a Motor Vehicle Without A Valid License pursuant to F.S.S. 322.03(1). The facts are as follows: On 5/17/2020 at approximately 0407 hours, I observed a white Toyota bearing NY tag JJJ1716 stopped in the middle of the 200 block of Via Palma with its reverse lights on. I then made contact with the driver who was sleeping in the driver's seat verbally identified as Amber Nicole Potter W/F DOB 9/27/1994. I then called out to Potter and advised her to put the vehicle in park, which she complied. I then had Palm Beach Communications run Potters information, which came back to Potter having only an ID Card. Potter at this point was ordered out of the vehicle, which she complied. Upon Potter stepping out of the vehicle I detected a strong odor of marijuana emanating from inside the vehicle. Potter was asked if she had marijuana on her person, which she stated she had "a little bit of weed" inside the vehicle. I then searched the vehicle and observed an orange pill stamped "b 973 30" in plain view in the center compartment of the vehicle. Officer Ardon was able to recognize the pill as a generic Adderall. Further search of the vehicle revealed half of the same type of pill and a small amount of marijuana. Potter was read her Miranda Warnings from a pre-printed card provided to me by the Palm Beach Police Department. Post Miranda Potter admitted the pills found in the vehicle were Adderall pills and that she knew she had marijuana in the vehicle. Potter also stated she knew she did not have a valid FL DL but borrowed the rental from a friend.
