

I spoke to Janice Alma Robson (W/F - 12/16/1979) via phone who advised her husband, Amir Gordon (W/M - 3/11/1973) and she got into a physical altercation at Home Depot. Robson advised they have been together for approximately three years. She advised she was waiting at Home Depot for a child exchange with their daughter, Emily Robson - Gordon (W/F - 10/31/2019). Robson advised Gordon had Emily in his vehicle (Gray Honda Pilot) and he was bringing Emily to Robson.

Robson advised she was parked in a parking space and Gordon stopped the vehicle in the middle of the parking lot. She advised Gordon got out of his vehicle and was angry. She advised he demanded she (Robson) give him her cell phone. Robson stated Gordon got angrier when she would not give him the cell phone and she got into his vehicle and drove off. Robson advised a few minutes later, Gordon came back. She stated Emily was sitting in the rear right passenger side of the vehicle. Robson advised when she was about to get Emily, Gordon forcibly grabbed her left arm and pulled on it. She advised when she escaped his grips, he would grab her right arm and also pushed her towards his vehicle. Robson stated she yelled at Gordon "please take your hands off me!" and "please stop!". She advised when she was able to grab Emily, Gordon told her "you are a fucking mess get your shit together" and drove off.

She advised the incident occurred on March 9th 2021 at approximately 1400 in front of Home Depot near the garden section parking lot. She advised she wanted to notify police at that time; however, was too terrified and afraid of Gordon. Robson stated she moved out of Gordon's residence (604 Sea Pine Way unit B Grenaches FL. 33415) a few months ago and she resides at 5400 south Williamson Blvd., Port Orange FL. 32128.

Robson advised there had been multiple physical altercation in the past with Gordon and she; however, did not report it because she was scared. I advised Robson to contact the Jupiter Police Department when she comes back in the area to retrieve a sworn statement and a domestic violence pamphlet. Robson advised she had multiple messages from Gordon regarding the incident. The screen shots of the messages were uploaded to Evidence.com. One of the screen shots had a message from Gordon to which it stated "I came and stood beside you and tried to pause your action momentum by holding your arm with my hand. I did that because you were in the action of unbuckling Emily who was sleeping and I wanted to get your attention and pause that action."


I checked Home Depot for any surveillance footage; however, they were unable to access the cameras at that time. I attempted to make contact with Gordon via phone; however, that had negative results. I made contact with Department of Children and Family via phone and spoke with Avea ID178. She advised they will take a report.

On April 12th 2021, I received surveillance footage of the incident at Home Depot from the Lost Prevention Officer (James Kirk). Due to where Robson and Gordon parked, it is slightly difficult to see the incident. The surveillance footage was uploaded to Evidence.com.


On April 23rd at approximately 0100 hours, I made contact with Robson at the Jupiter Police Department. I obtained a sworn statement from Robson utilizing my Department issued Body Worn Camera. Robson's statement was consistent with the initial statement she made and the surveillance footage from Home Depot. She also advised when she was trying to get Emily out of the car seat, she cut and strained her thumb. She advised Gordon used his full body weight against her while she was trying to get Emily and she (Robson) felt trapped. I issued Robson a Domestic Violence brochure and advised her to contact the Jupiter Police Department if she had any questions or concerns.

As of April 26th 2021, Gordon has not return my phone call or attempted to contact me. Robson advised Gordon was not allowing her to see Emily and wanted Robson to take three Covid Tests. I advised charges for Gordon would be filed with the State Attorney Office.

Based on my investigation, I found probable cause to charge Amir Gordon for Domestic Battery because he did actually and intentionally touch or strike Janice Alma Robson against the will of Janice Alma Robson or did intentionally cause bodily harm to Janice Alma Robson and Janice Alma Robson was a family or household member of Amir Gordon, contrary to Florida Statute 784.03(1), (1 DEG MISD)

Based on my investigation, I found probable cause to charge Amir Gordon for False Imprisonment because he did forcibly or secretly confine, imprison or restrain Janice Alma Robson, against that person's will and without lawful authority, contrary to Florida Statute 787.02(2). (3 DEG FEL)
