UPON COMING UP TO THE INTERSESECTION OF 107TH AND GULF BLVD THE DRIVER TURN ON THE TURN SIGNAL, BUT DID NOT GO INTO THE TURN LANE AND PROCEEDED STRAIGHT. ONCE I INITIATED MY EMERGENCY LIGHTS FOR THE VEHICLE TO PULL OVER, THE VEHICLE PROCEEDED FROM 108TH AVE TO 112TH AVE WHERE THE TRAFFIC STOP WAS CONDUCTED. THE VEHICLE STOPPED IN THE MIDDLE OF THE STREET. AFTER MAKING CONTACT WITH THE DRIVER A SRTONG ODOR OF AN ALCHOLIC BEVERAGE EMANATED FROM THE DRIVER WHEN SHE SPOKE. 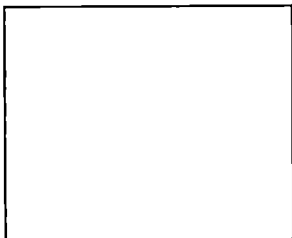
