RAZZANO</b> admitting to the below facts. <input checked="" type="checkbox"/> was found to have committed the below acts, resulting from my (described) investigation.</p> <p>On the <b>28</b> day of <b>April</b>, <b>2021</b> at <b>18:59</b> (Specifically include facts constituting cause for arrest.)</p> <p>On Wednesday, April 28, 2021 at approximately 1512 hours, I was dispatched to the Allure neighborhood gym located at 4427 Main St., in reference to a male who had just been pepper sprayed in the face.</p> <p>Upon arrival at the Allure leasing office, I made contact with the victim, Anthony Calderaio (WM 10/5/60), who was sitting outside on the bench, shirtless, and wearing grey sweatpants. Calderaio's face was visibly red and wet. He was attempting to pour water on his face to wash away the pepper spray. PBCFR arrived on scene and assisted in decontaminating Calderaio. After a few minutes, Calderaio was able to breathe normally and tell me what happened.</p> <p>Calderaio advised me the following in a sworn statement: He was inside the community gym, in the North West corner. He advised he briefly stopped working out when he observed his neighbor, Amy, walk through the gym from the North East entrance. He stated he immediately ignored her and turned the other way because he and Amy have had some issues recently, with the most recent being a few days ago. He stated he was in the gym when Amy walked through and threatened him with a stun gun. He stated he turned towards the wall when Amy began yelling at him saying something along the lines of "are you going to rape me". He stated he saw her walk towards him and he stepped back when she sprayed him with pepper spray. He stated he immediately exited the gym through the North East doors. I went inside the gym to observe where the incident occurred. I immediately observed a reddish, orange spray on the wall where Calderaio stated he was standing. I observed his water bottle, and keys that were left behind on the table.</p> <p>I made contact with the property management who was able to provide me with video footage from inside the gym. The camera is located in the South West corner and faces the north end of the gym. It is motion activated; therefore, it did not completely pick up the beginning of the altercation. The video does show a female, wearing jeans and</p>

<p>white shirt, later identified as Amy Beucher (WF 9/22/70), lunging in the direction of where Calderaio explained the incident occurred. The incident occurred at approximately 1507 hours. (Please note that the video camera time stamp is one hour ahead of real time).</p> <p>I made contact with Beucher via landline at approximately 1607 hours; I introduced myself as Officer Razzano with the Jupiter Police Department and asked if I was speaking with Amy, she verified that I was speaking with Amy. I asked her how she was doing and she stated "not good". Beucher sounded as if she was crying on the phone, and I asked her to meet with me in person to speak about the incident. Beucher stated she was afraid of Calderaio and asked if he was present. I stated he was not and that there were three police officers present at the scene, and that she would be safe. Beucher originally stated to me on the phone that she did not want to walk towards our location because she did not want to walk past the gym or Calderaio's apartment. Beucher eventually showed up after calling two other individuals to meet myself and the other Officers at the scene first. I asked Beucher if she could tell me what happened and she immediately started to get emotional and attempted to cry. I advised her that she would need to speak clearly so that I could understand what she was saying. Beucher began to talk about all the incidents leading up to today, and stated there has been ongoing issues with Calderaio over the last few days. She stated she was fearful of Calderaio due to his vulgar language towards women. She began to tell me about the incident with the stun gun, stating she never threatened him with it; however, when I asked her how he knew she even had one she stated she might have slightly pulled it out of her purse to make him aware that she did have one on her that day. I asked her to explain what happened today and she stated the following: She was walking through the gym as a cut through from the North East entrance doors. She stated she did not see Calderaio in the gym when she first walked in; however, Calderaio's position in the gym would have been visible almost immediately from the doors she walked in through. She then stated that once she saw him, she stopped dead in her tracks and heard him say something about how he "was going to get her good". Beucher stated she pointed her pepper spray keychain in his direction, but was not sure what was going to happen once she actually sprayed it. She stated she sprayed Calderaio and walked out of the gym because she was afraid. I asked Beucher several times about the behavior or actions displayed by Calderaio that made her feel threatened. Beucher could not describe why she was in fear today, other than there has been ongoing issues with Calderaio in the past. Based on Calderaio's and Beucher's statements, no threats or actions were done by Calderaio today to put Beucher in fear. It should be noted that Calderaio was in the gym minding his own business when Beucher entered the gym with no intentions of utilizing the gym for working out. Beucher stated several times that she knows Calderaio works out in the gym and they have encountered each other in there several times before today. It is unknown why Beucher would walk through the gym if she was as fearful of the victim as she says she was. It should also be noted that a reasonable person in fear enough to deploy pepper spray at someone would reasonably contact police after such an incident took place. After almost an hour,</p>

Based on the aforementioned facts, and the clear physical evidence inside the gym, probable cause exists to charge Amy Beucher with battery pursuant to FL SS 784.03.

Amy Beucher did actually and intentionally touch or strike \*(Calderaio) against the will of \*(Calderaio) {or} did intentionally cause bodily harm to \*(Calderaio), contrary to Florida Statute 784.03(1).
