The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a blue 2016 Toyota Highlander, 4 door SUV, Florida tag 5180QX. The defendant was stopped for driving at night without head lights on (no head lights and no tail lights). The defendant began spraying perfume in the interior of the vehicle at the start of the traffic stop. The defendant appeared confused, and even when told, and shown, that her head lights were off she didn't seem to comprehend. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendants eyes were red and watery, and her pupils were dilated and reacted very little to light. Her face was slightly flushed around the cheeks. The defendant dropped numerous items into her lap while fumbling with her credit card wallet, including a large number of US gold \$1 coin. The defendant stated she drank two shots of tequila and drank one beer tonight. The defendant swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant provided breath samples of .069% BrAC and .070% BrAC. The defendant provided a urine sample. The defendant admitted to having taken 1/4 bar of Ecstasy at around midnight. A search of the defendant's purse, incident to her arrest was conducted. A clear and white pill bag was located within a side pouch within the purse, and this bag contained approximately 1.5 grams of a white powdery substance. The white powdery substance field tested (at CBTU) positive for cocaine. The defendant admitted knowledge of the cocaine being in her possession. The defendant was positively identified by her Florida DL. The defendant is 19 years of age.
