of Factors hand while we were en route. I spoke to Scott and he advised that Horburg had been drinking and had physically hit him. He advised that they were in an intimate relationship as boyfriend/girlfriend and had lived together as such for a lengthy period of time.

At this point, based on Ofc. Lowe's observations, I had probable cause to arrest Horburg for domestic battery for hitting Factor. Ofc. Lowe and I cleared the first floor of the residence and determined that Horburg must have fled upstairs. I observed spilled wine all over the front living room area as if there had been a disturbance. While at the bottom of the stairs and during our ascent to the second floor, I gave Horburg multiple loud commands advising her that I was the police and ordered her to come to me. She failed to comply with these orders. Horburg eventually opened the door to her bedroom as we were about to enter, after we had given commands for her to come to us. I explicitly advised her that if she did not show herself that she would be considered obstructing my investigation, which is what she did. As Horburg opened the door, she was completely nude. I advised her to put on clothing and she put on a robe. We then relocated downstairs, where she got dressed. I then placed Horburg under arrest for domestic battery and resisting arrest without violence. I transported her to JPD for processing. While at JPD, Horburg slipped her handcuffs to the front and then attempted to strangle herself with the chain linking the hand partitions. She had to be hobbled and secured with extra restraints. I then transported her to county jail. BWC.
