The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/19/2019 at approximately 2142 hours, the defendant was involved in a traffic crash with another vehicle near 10122 Majestic Palm Cr. causing approximately \$150 damage, see report #19-907295. The defendant attempted to leave the scene of the crash but was blocked by the victim. Upon Deputy Ortiz 258031 contact with the defendant, he noted she had bloodshot watery eyes and slurred speech, along with the odor of an alcoholic beverage emitting from her breath. Upon my contact with the defendant, she was still in the front driver's seat of her vehicle, she had a strong odor of alcoholic beverage and advised she takes Xanax also. During the completion of SFSE's she displayed several indicators of impairment. Once at CBT, she provided 2 lawful breath samples, after a 20 minute waiting period. The breath samples provided were 0.128 and 0.122 %BAC. I issued the defendant DUI citation AD0BLLE. The defendant identified herself verbally and was confirmed via D.A.V.I.D. query.
