required in violations of Florida State Statute 316.061. A license plate of "EUMV06" was provided as being attached to the white Kia, Additionally, a witness to the crash (Lynette Latrell Davis) contacted the TBRCC advising that she witnessed the hit-and-run and could identify the driver. The victim also advised that he could identify the driver. Due to a crash causing lane closures on the Howard Franklin Bridge, traffic was stopped and intermittently slow moving. Trooper R. Refuse (3357) stopped to meet with the victim on Interstate 275, west (southbound) of State Road 60. At approximately 09:50 PM, I, Trooper T. Sheinberg (4234) arrived on-scene to assist Tpr. Refuse. At approximately 09:56 PM, the TBRCC was advised that Sqt. M. Simmons (2873) had stopped the mentioned Kia near mile marker 36. The victim described the Kia driver (DEFENDANT) as an Indian male with short black hair, partial beard, and wearing black shirt with khaki pants and glasses. Tpr. Refuse, the victim, and I relocated to Sgt. Simmons to meet with the defendant who was detained. Sgt. Simmons advised that the defendant was the driver and sole occupant of the Kia. While interacting with the defendant, I observed a strong odor of an alcoholic beverage emanating from his facial region. Additionally, the defendant was providing short responses and failing to make eye contact. Tpr. Refuse then approached the defendant to speak further about the incident. At approximately 10:26 PM. I read the defendant his Miranda Warnings from my agency issued card. The defendant acknowledged understanding and continued to speak with me. The defendant advised he was the driver at the time of the crash. He advised that he had a female passenger with him who he dropped off at Burger King post-crash (this was incorrect information). The defendant advised he was the third vehicle in the crash and did not need to stay on-scene. The defendant acknowledged post-Miranda that he was the driver of the vehicle at the time of the crash, involved in the crash, and fled the scene of the crash without providing his information. The defendant was asked to voluntarily perform standardized field sobriety exercises, in which he performed poorly on Horizontal Gaze Nystagmus, Vertical Gaze Nystagmus, Walk-and-Turn, and One Leg Stand.
