## PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 09/09/2020 at approximately 00:16hrs, I was called to the scene of a traffic stop near the intersection of Summit Blvd & Harper's Ferry Blvd which is located in unincorporated West Palm Beach, Palm Beach County, Florida. I arrived at the scene at approximately 00:24hrs. D/S V. Ebel #29608 relayed to me, and completed a written signed sworn supplemental Probable Cause Affidavit, that she had stopped the defendant's vehicle, a 2019 silver Nissan Sentra bearing FL tag JRA-E26, because the defendant failed to stop on a steady red traffic signal before making a right turn at Summit Blvd and S Haverhill Rd. D/S Ebel noticed that the defendant had articulable indicators of impairment, so she called for a DUI unit to conduct a possible DUI investigation. D/S Ebel identified the defendant, to me, as the driver/sole occupant of the vehicle, at the time of the stop.

### OBSERVATION OF DRIVER:

Upon making contact with the driver who was identified by her Florida driver license as "ANDREA BARATH", I immediately detected an obvious and strong odor of an unknown alcoholic beverage emitting from her person and face area prior to donning my PPE. This odor intensified as I spoke to Barath even after both of us wearing PPE. Barath had glassy and glazed eyes. Barath's speech was slurred and thick with an accent. Barath had poor coordination. Barath had an unsteady gate while walking to my patrol vehicle and had difficulty following and remembering directions given to her. Barath was wearing a gray t-shirt, black/white legging jeans, and white sandals. All the clothing appeared neat.

### DRIVER'S STATEMENTS:

Pre-Miranda: Barath stated she had a couple glasses of wine at a friend's house.

Barath consented to breath and declined to participate in the Q&A.

### ODORS:

A strong and obvious odor of an unknown alcoholic beverage was emitting from her person and face area which intensified as I spoke to Barath.

## GENERAL OBSERVATIONS

SPEECH: Barath's speech was slurred and thick with an accent.

ATTITUDE: talkative, polite, cooperative, reserved, calm

CLOTHING: gray t-shirt, black/white legging jeans, and white sandals.

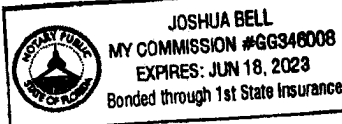

**Other Observations:**

Barath would sway roughly in a side to side front to back pattern throughout the task. Barath did touch the tip of the pen as directed to positively identify the point to be tracked. Barath was reminded numerous times to track the pen with her eyes only. Barath failed to keep her head still while tracking the stimulus. Barath had VGN

**WALK & TURN:**

I explained and demonstrated the instructions for the "Walk & Turn" to Barath who stated she understood. During the task, I observed Barath to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Barath could not maintain her balance while listening to instructions. Barath stepped out of the instructional stance during the demonstration to catch her balance. Barath started the task before being instructed to do so. Barath would stop walking to steady herself with pauses to regain balance. Barath missed heel-to-toe steps and stepped off the line. Barath used her arms for balance. Barath performed an improper turn by turning other than which was demonstrated. Additionally, Barath performed the incorrect number of steps.

**ONE LEG STAND:**

I explained and demonstrated the instructions for the "One Leg Stand" to Barath who stated that she understood. During the task, I observed Barath to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Barath continued to sway while balancing on one leg. Barath used her arms to balance raising them more than 6 inches from her sides. Barath failed to count out loud or properly by thousands as instructed. Barath put her foot down to regain balance numerous times before the 30 seconds had elapsed.

**FINGER TO NOSE:**

I explained and demonstrated the instructions for the "Finger to Nose" task to Barath who stated that she understood. During the task, I observed Barath to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Barath did not keep her eyes closed and had to be reminded numerous times. Barath's index finger did not touch the tip of the nose on 5 of 6 attempts. Barath searched for the tip of her nose using the finger to find their nose prior to touching the tip. The sequence used for this task was L, R, L, R, R, L.

**ROMBERG ALPHABET:**

I explained and demonstrated the instructions for the "Rhombert Alphabet" task to Barath who stated that she understood. During the task, I observed Barath to sway roughly in a side to side, front to back pattern throughout the demonstration phase. Barath would sway more than 2 inches. Barath correctly recited the alphabet.

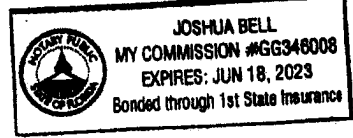
