The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 08 day of DECEMBER, 2019,

at approximately 1:08 AM, at 901 SEMINOLE BLVD, in Pinellas County did:

THEN AND THERE UNLAWFULLY HAVE IN HIS POSSESSION, CUSTODY, OR CONTROL A CERTAIN CONTROLLED SUBSTANCE, TO-WIT: A YELLOW RECTANGULAR PILL WITH MARKINGS OF "R|0|3|9" WHICH WERE IDENTIFIED AS ALPRAZOLAM 2 MG PRESCRIPTION ONLY SCHEDULE 4 THROUGH DRUGS.COM.

DEFENDANT WAS PLACED INTO CUSTODY FOR DUI. DURING AN IMPOUND INVENTORY OF HER VEHICLE, OFFICERS LOCATED A PURSE ON THE PASSENGER SEAT WHICH CONTAINED THE PILL DESCRIBED ABOVE. POST-MIRANDA, THE DEFENDANT ADMITTED TO KNOWLEDGE OF THE PILL IN HER PURSE PRIOR TO BEING TOLD THAT OFFICERS HAD FOUND IT. SHE STATED THAT THE PILL BELONGED TO HER ROOMMATE (WHO WAS NOT WITH HER AT THE TIME OF THE ARREST) AS SHE KEEPS HER MEDICATIONS FOR HER. THERE WAS ONLY THE SINGULAR PILL AND THERE WAS NOT IN ANY TYPE OF PRESCRIPTION BOTTLE.

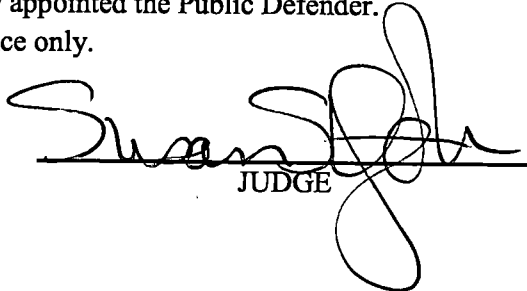
ADVISORY AND SOLVENCY HEARING

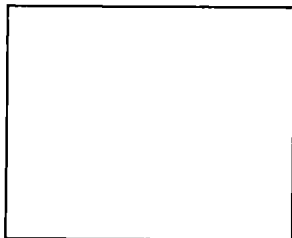
