The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 01/03/2019, at approximately 0226 hours, at John Moore Rd / Jeffrey Dr, Brandon, FL 33511, Deputy Price #252762 conducted a traffic stop on a 2019 silver Jeep Cherokee (FL tag: HVJZ07 / VIN: 1C4PJLCB7KD243049) accelerating / decelerating rapidly, stopping without cause, and with the possibility of being ill, tired, and impaired. Upon making contact with the driver, Deputy Price observed her to have bloodshot watery eyes, slurred speech, and the odor of an alcoholic beverage on her breath. I observed the same indicators, requested for the driver to submit to field sobriety exercises, which she refused to perform. I explained to the driver that without observing her conduct the exercises, I would be forced to place her under arrest for DUI based on the totality of circumstances. The driver understood and again, refused. While at CBT, the Implied Consent Warning was read to the defendant where she advised she understood and when asked if she would provide breath samples, she stated "No." Per the defendant, she refused breath samples on her last DUI arrest on August 26, 2019, which was confirmed by Deputy Andrews #255424 who was at CBT with me, which was the prior arresting deputy. Per DAVID, the defendant went to a hearing for the refusal on 09/27/2019. The defendant was positively identified via her DAVID photograph.
