The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On September 24, 2020 I observed a white 2005 Toyota Sequoia bearing Florida license plate#: DHCU62 (VIN: 5TDZT38A25S254505) traveling Eastbound on Bearss Av. W. approaching the Florida Av. intersection. The vehicle changed lanes partially in the left turn lane (half the vehicle), then moved back into the outside through lane, before making a right hand turn in the intersection, driving South on Florida Av. N. crossing the inside open lane and right hand turn lane of Bearss Av. W. in violation of Florida State Statutes 316.087(1)c [changing lanes within 100 feet of marked intersection] and 316.151 (1)(a) [must stay close to right hand curb when making right hand turn on approach]. Upon contact with the defendant (driver) I observed him to have bloodshot watery eyes, to be lethargic, slow verbal responses, to be disoriented, to provide inconsistent responses, and I detected the odor of an alcoholic beverage emanating from his breath. The defendant performed standardized field sobriety exercises poorly indicating impairment. Once at Central Breath Testing, after being advised of the Implied Consent Warning, after a twenty-minute observation period, the defendant provided lawful breath samples showing a breath alcohol concentration of .189/.172. While next to the instrument, the defendant spontaneously stated "I had three beers." I confirmed the defendant's identity via DAVID. Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge.
