The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 14 day of MARCH, 2020, at approximately 1:40 AM, at WEST BAY DR/HARBOR VIEW LN, BELLEAIR BLUFFS, FL 33, in Pinellas County did:

UNLAWFULLY OBSTRUCT OR OPPOSE DEPUTY C MILLER, A DULY AND LEGALLY CONSTITUTED LAW ENFORCEMENT OFFICER OF THE PINELLAS COUNTY SHERIFF'S OFFICE, WHILE IN THE LAWFUL EXECUTION OF A LEGAL DUTY, WHICH CONSISTED OF TRAFFIC INVESTIGATION WITHOUT OFFERING OR DOING VIOLENCE TO THE PERSON OF THE OFFICER.

ON THE ABOVE DATE AND TIME, I CONDUCTED A TRAFFIC STOP ON A VEHICLE FOR SEVERAL TRAFFIC VIOLATIONS. CONTACT WAS MADE WITH THE DRIVER OF THE VEHICLE, AS WELL AS THE DEFENDANT, WHO WAS THE FRONT SEAT PASSENGER OF THE VEHICLE. WHILE SPEAKING TO THE DRIVER OF THE VEHICLE, I OBSERVED NUMEROUS SIGNS OF INTOXICATION. I WAS SPEAKING TO THE DRIVER, WHEN THE DEFENDANT INTERRUPTED ME AND STATED THAT HE WAS "OFF DUTY." THE DEFENDANT BEGAN TO IMPEDE MY INVESTIGATION BY TALKING OVER ME AS I WAS SPEAKING TO THE DRIVER. I ASKED THE DEFENDANT IF HE WAS A LAW ENFORCEMENT OFFICER AND IF SO, WHAT AGENCY HE WAS EMPLOYED BY. THE DEFENDANT DID NOT ANSWER MY QUESTION. I ASKED THE DEFENDANT TO PROVIDE IDENTIFICATION, WHEN HE STATED "MY LICENSE OR MY BADGE?". I REQUESTED THE DEFENDANT TO PROVIDE HIS DRIVER'S LICENSE, AND AGAIN ASKED WHAT AGENCY HE WAS EMPLOYED BY. THE DEFENDANT THEN ADVISED "ATF." (BUREAU OF ALCOHOL, TOBACCO, FIREARMS, AND EXPLOSIVES) A LAW ENFORCEMENT DATABASE QUERY YIELDED THAT THE DEFENDANT'S DRIVER'S LICENSE WAS SUSPENDED, WHICH CAUSED SUSPICION THAT HE WAS NOT A LAW ENFORCEMENT OFFICER. UPON FURTHER QUESTIONING, THE DEFENDANT STATED THAT HE WAS NOT A LAW ENFORCEMENT OFFICER. THE DEFENDANT'S ACTIONS WILLFULLY INTERRUPTED MY DUI INVESTIGATION.
