The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 18 day of JANUARY, 2020, at approximately 3:20 AM, at 210 1 AV N @JOEY BLOOKLYNS PIZZA, in Pinellas County did:

WAS THEN AND THERE INTOXICATED AND CAUSED A PUBLIC DISTURBANCE, TO-WIT:

THE DEF WAS FOUND TO BE HIGHLY INTOXICATED. HE HAD BLOOD SHOT WATERY EYES, SLURRED SPEECH, WAS UNSTEADY ON HIS FEET, AND HAD A STRONG ODOR OF ALCOHOL EMANATING FROM HIS PERSON. THE DEF WAS PHYSICALLY REMOVED FROM JOEY BROOKLYNS PIZZERIA BY STAFF AFTER BEING BELLIGERANT AND ATTEMPTING TO FIGHT WITH STAFF. CONTACT WITH THE DEF WAS MADE OUTSIDE THE ESTABLISHMENT. HE WAS GIVEN MULTIPLE OPPORTUNITIES TO LEAVE AND STOP CAUSING A DISTURBANCE. THE DEF REFUSED TO LEAVE WHILE VERBALLY TAUNTING STAFF AND GIVING THEM THE MIDDLE FINGER CAUSING SEVERAL CITIZENS TO STOP AND WATCH THE SPECTACLE. HE WAS TAKEN INTO CUSTODY AND UNCOOPERATIVE WITH QUESTIONING.

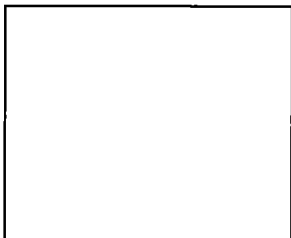
