(Specifically include facts constituting cause for arrest.)</p> <p>On the above date, I was working a Palestinian protest located at the 7775 block of Glades Rd, Boca Raton Fl. While working the protest, Deputy Devriend, Cpl. Dallesandro and I could hear a loud horn activated toward the protest. We all observed a gray in color Audi Q5 SUV blowing the horn continuously without interruption towards the crowd in an attempt to silence them. The Audi was parked at an angle in the parking lot facing towards the crowd within an approx. 50 feet away. Cpl. Dallesandro asked the driver, Andrew Klein to stop blowing his horn. The Palestinian crowd at the protest started to gather around on the sidewalk, near the area of the car yelling at Klein and another female trying to interrupt their protest. Klein was told to leave and to stop instigating the crowd. Klein advised that he was not happy with their protest and could not be forced to stop blowing his horn. We advised him that he was instigating the crowd and causing a disturbance at their protest. Klein was violating the Disorderly Conduct statute since his acts were of a nature to corrupt the public morals, or outrage the sense of public decency, or affect the peace and quiet of persons who may witness them, or engages in brawling or fighting, or engages in such conduct as to constitute a breach of the peace or disorderly conduct, shall be guilty of a misdemeanor of the second degree. We tried to explain to him it was also against the law to blow his horn since there was no emergency and it was not reasonably necessary to ensure safe operation, give audible warning with his or her horn under State Statute 316.271 (3). At this time, another female anti-protester driving a blue vehicle parked in the parking spot in front of the Audi driven by Klein. The unknown female was trying to incite the Palestinian protesters by saying statements to them. I asked Klein to leave the area and stop inciting the crowd. He then exited his vehicle and ran over the female. The female had started to yell at me that she was being threatened by the Palestinian protesters at which I was trying to find out about her complaint. Klein decided to exit his vehicle and stated that he was going to help her. I explained to him that it was our job as law enforcement to handle it. Every time I tried to talk to the female, Klein would over talk me and refused to let me investigate her complaint. Klein then wanted to argue why we would write him a ticket about his excessive use of horn. He grabbed his cellphone from his car and started to record me. I explained to him that since he wanted to start recording, he changed his argumentative attitude and wanted to argue about the horn issue. I had given multiple warnings prior to leave and stop instigating the crowd. At this time, Ameer Omar Shihadeh (Palestinian Protester) walked over to Klein and started arguing about their views. They started to record each other on their cell phones as they yelled at each other. Ameer's face got closer to Klein's phone at which time Ameer stated that his space was invaded by Klein. Ameer purposely put his face against Klein's phone to have him record him. Ameer got mad and slapped Klein's phone away from his hand. Klein's phone flew in the air and towards his back. Klein immediately stated that he wanted Ameer to go to jail for battery.</p>

<p><b>Ameer was handcuffed without incident. Due to this incident occurring, the crowd started to gather again around the two arguing. Deputy Devriend was still talking to the female which stated that a crime did not occur to her and wanted to leave. Klein continued to cause a disturbance and refused to calm down or listen to stop inciting issues. Since Klein refused to cooperate and stop obstructing our investigations, I advised that he was under arrest for the disorderly conduct. I grabbed Klein's right wrist in attempt to make an arrest. Klein tensed up, pushed his arms forward, and stated that he was not going to jail. I tried to grab his hand and around his chest to conduct a take down maneuver due to his active resistance. Deputy Devriend had his left hand and noticed that Klein tensed and resisted. We had to scuffle with Klein since he refused to lay on the ground or be placed into handcuffs. Due to his movements I ended up bear hugging his upper mid section and tried to wrestle him to the ground. As we ended up on the ground, Klein received a scratch to his mouth by unknown means. Klein continued to resist as many deputies tried to handcuff him. I had to hold his to prevent further injury from the ground and to prevent him from spitting on the deputies during his continued resistance. Klein was transported from the scene to the command post without incident. Sgt. Zachary Burke (Boca Raton PD) was parked to the west of the incident, two spaces over in an unmarked vehicle. He observed the entire incident and filed a sworn written statement. A PBSO Drone was flying over head (flown by Deputy Martin) who captured the entire incident on drone video.</b></p>

ON 05/21/2021 AT AT APPROXIMATELY 1730 HRS, I BACKED UP D/S DALLESSANDRO # 8297, WHO WAS ASKING A W/M, LATER IDENTIFIED AS ANDREW KLEIN DOB 05/31/1967, TO STOP HONKING HIS HORN AT THE PROTESTORS. MR. KLEIN WAS ARGUING WITH D/S DALLESSANDRO TELLING HIM HE DIDNT HAVE TO STOP, IT WAS HIS RIGHT TO FREE SPEECH AND A CONSTITUTIONAL RIGHT. AN UNKNOWN WOMAN, PARKED IN FRONT OF MR. KLEIN, IN THE SAME PARKING, WAS STANDING ON HER CAR VIDEOING THE PROTESTORS ON HER CELLPHONE, WHEN THE PROTESTORS STARTED YELLING AT HER. SHE GOT OFF THE CAR WAS WALKING OVER TO SGT YODER AND I, SAYING SHE WAS THREATENED. MR. KLEIN WALKED OVER TO US AND SAID WE NEEDED TO INVESTIGATED THIS, SHE WAS THREATENED. AS SGT. YODER SPOKE WITH HER, MR. KLEIN CONTNUED TALKING TO SGT YODER. I WALKED OVER TO MR. KLEIN AND TOLD HIM HE NEEDED TO LEAVE, THAT HE WAS OBSTRUCTING SGT. YODER'S INVESTIGATION. MR. KLEIN SAID HE DIDN'T HAVE TO LEAVE ,THIS IS A FREE COUNTRY IM ALLOWED TO BE HERE. HE CONTINUED SAYING, THEY'RE HERE AS HE POINTED TO THE PROTESTORS ON THE SIDEWALK. I TOLD MR. KLEIN HE NEEDED TO LEAVE, YOUR OBSTRUCTING THE SGT., HE CANT TALKING TO THE LADY WITH YOU INTERFERING. MR. KLEIN CONTINUED TELLING SGT YODER ABOUT HIS RIGHT TO HONK HIS HORN DEMANDING SGT YODER TO GIVE HIM THE STATUTE NUMBER SO HE COULD LOOK UP THE STATUS HIMSELF. SGT YODER WAS UNABLE TO SPEAK WITH THE WOMAN BECAUSE OF MR. KLEIN. SO I BEGAN TO SPEAK WITH HER ABOUT THE SITUATION AS SGT YODER ADDRESSED MR. KLEIN AND THE OBSTRUCTION. AT THIS TIME ONE OF THE PROTESTORS STARTED ARGUING WITH MR. KLEIN. I WAS FACING AWAY FROM THE ARGUMENT BUT I HEARD SOMEONE CALL SOMEONE A TERRORIST AND THEN A CELL PHONE FLEW BY MY LEFT SIDE. I TURNED AROUND TO SEE A GUY IN A WHITE SHIRT TELLING MR. KLEIN NOT TO CALL HIM A TERRORIST AND HE WAS NOT A TERRORIST. MR. KLEIN ASKED SGT. YODER IF HE SAW THAT AND SGT. YODER ASKED MR. KLEIN IF HE WANT TO PRESS CHARGES AND MR. KLEIN RESPONDED THAT HE DID. SGT YODER ARRESTED THE INDIVIDUAL WITH INCIDENT. AFTER THAT INDIVIDUAL WAS ARRESTED, SGT YODER CAME BACK TO THE SCENE AND WAS TALKING TO MR. KLEIN. I HEARD SGT YODER TELLING MR. KLEIN HE WAS UNDER ARREST. SGT YODER TOOK CONTROL OF MR. KLEIN'S RIGHT ARM AND I TOOK CONTROL OF MR.KLEIN'S LEFT ARM. MR. KLEIN WAS ACTIVLY RESISTING, NOT COMPLYING TO SGT YODER'S ORDER TO STOP RESISTING. MR. KLEIN WAS TAKEN TO THE GROUND AND HANDCUFFED. THE WOMAN I WAS SPEAKING WITH BEFORE, HAD LEFT THE AREA DURING ALL THIS.
