The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 7/25/2021, at approximately 1912 hours, at Windhorst Rd. W. / June Lake Ln., Brandon, FL 33510, Deputy Juncal (ABN 253879) conducted a traffic stop on a gold Saturn (bearing TN tag 8X56H8 / VIN: 5GZER13778J190801) for (FSS 316.089) Failure to Maintain Lane after observing the vehicle swerve into the oncoming lane causing a vehicle to divert off the roadway to avoid collision, overcorrect and swerve onto the shoulder, then swerve into oncoming lane and onto the shoulder a second time. Deputy Juncal observed the defendant to have glassy, watery, bloodshot eyes and slow, slurred speech. Based on the observed indicators of impairment, Deputy Juncal requested a DUI investigator respond to the scene. Upon my arrival, I observed the same indicators of impairment listed above, as well as detected the odor of an alcoholic beverage emitting from the defendant's breath. The defendant was given the opportunity to perform field sobriety exercises, which he did poorly, indicating impairment. Subsequent to arrest, the defendant provided breath samples of .195/.197 after a twenty minute observation period. While conducting an inventory search of the vehicle, Deputies located an open container of McCormick Vodka (750 mL) on the front passenger seat of the vehicle. The defendant was identified via their Tennessee driver's license card.
