PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

I was westbound on PGA Boulevard passing N Military Trail when I observed a red Toyota Corolla (bearing MA tag 6NG384) facing eastbound on PGA Boulevard stopped with the driver's door open. I got behind the Corolla and as the light changed, the vehicle proceeded forward slowly and made the left turn to go northbound on N Military Trail. I activated my emergency equipment signaling the driver to pull over, the driver came to final rest in the entrance to the Double Tree Hotel in the 10900-BLK of N Military Trail. I identified the driver via F/NCIC as Andrew Thomas Abbott, provided by his Massachusetts Vehicle Registration.

OBSERVATION OF DRIVER:

Abbott was dazed and confused. He had the strong odor of an unknown beer coming off his breath as he spoke. His eyes were bloodshot, glassy and spoke with a slur. Abbott swayed while walking and was unable to maintain his balance during the exercises.

DRIVER'S STATEMENTS:

Stated he left his DL at the bar, Jumby Bay Bar (1203 Town Center Dr #101, Jupiter, FL 33458). Stated he drank about 5 beers starting around 15:00hrs. Stated he left work in Tequesta and went to Square Grouper in Jupiter where he had 2 beers, then went to Jumby Bay where he had an additional 2 beers. Later Abbott stated he went to Rachel's off 45th Street in West Palm Beach where he had 2 beers and clarified he had 3 beers at Square Grouper. Did not have any medical conditions or issues with his eyes. Stated he got turned around when leaving Jumby Bay and believed he was still in Jupiter.

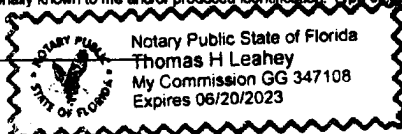

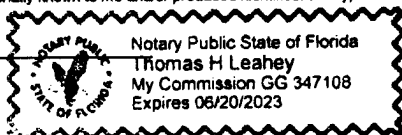
