at approximately 12:20 AM, at 151 7 ST S APT #511, in Pinellas County did:

DID INTENTIONALLY OR KNOWINGLY TOUCH OR STRIKE, AGAINST THE WILL OF GEORGE KARAKATSANIS THEREBY CAUSING GREAT BODILY HARM, PERMANENT DISABILITY, OR PERMANENT DISFIGUREMENT TO GEORGE KARAKATSANIS.

DEF DID AND THEN THROW AN APPROX 30 OZ "YETI" CUP WITH LID, ACROSS THE KITCHEN TOWARDS THE BEDROOM DOOR OUT OF ANGER. THE CUP/LID INCIDENTALLY STRUCK THE VICTIM ON THE RIGHT SIDE OF THE VICTIM'S HEAD, BEHIND HIS EAR CAUSING AN APPROX 1" LACERATION. DEF AND VICTIM HAVE BEEN IN A DATING RELATIONSHIP FOR APPROX 3 MONTHS, DO NOT LIVE TOGETHER, AND HAVE NO CHILDREN IN COMMON. *POST MIRANDA* DEF ADMITTED TO THROWING THE CUP ACROSS THE ROOM, DID NOT THROW IT AT THE VICTIM, AND ATTEMPTED TO RENDER AID TO THE VICTIM.

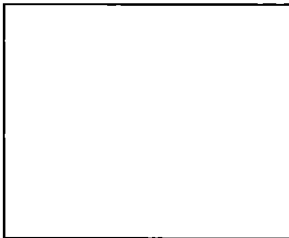
