The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 3/13/2020, at approximately 2217 hours, Corporal B. Dobson ABN 4809 conducted a traffic stop at 301 Hw N / Sligh Av E on a black Mitsubishi bearing FL tag CZDP64 (VIN:JA4AP3AU8KU035572) due being in fear the driver of the vehicle was either ill, tired, or impaired based on their driving pattern. Cpl Dobson observed the defendant operating the vehicle and detected signs of impairment. Affiant responded to the scene, detected an odor of an alcoholic beverage emanating from her breath, her eyes were bloodshot and glassy, her speech was slurred, and she was unsteady on her feet. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant refused to provide a lawful breath sample to determine her breath alcohol content (BrAC). Affiant read Implied Consent to the defendant in room 1 of Central Breath Testing, she understood and replied "No, sir." The defendant was identified via FL DL. The defendant was given a DUI citation A2VEHTE which reflects the DUI charge.
