The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/28/2019, at approximately 0155 hours, near the residential address of 4917 Oakshire Drive, Tampa, Florida 33625 Lieutenant J. White ABN: 4569 observed the defendant operating a silver 2019 Lexus NX 200t bearing Florida tag Y38NTK with an assigned VIN of JTJYARBZ0K2118442 driving in an erratic manner and failing to stop a solid red traffic light. Upon Lieutenant White's contact with the defendant/driver, he observed multiple indicators of impairment. Upon the affiant's contact with the defendant, I smelled the faint odor of an alcoholic beverage emitting from her breath, she had slurred speech, slow verbal communication, a red in color face, and she had bloodshot watery/glassy eyes. The defendant elected to participate in field sobriety exercises and while doing so, she showed further indicators of impairment. Post Miranda, the defendant admitted to consuming three alcoholic beverages prior to operating her motor vehicle. After taking the totality of the circumstances into consideration, the defendant was placed under arrest for DUI. The defendant was transported to University of South Florida Police Department and she provided to valid breath samples of .178 and .176. I further identified the defendant via her DAVID photograph.
