The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 3/3/2021, at approximately 2253 hours, Deputy S. Ross ABN 129331 conducted a traffic stop at Dale Mabry Hw N / Little Rd on a white Tesla, bearing FL tag 159XQQ (VIN:5YJYGDEE2MF083593) for traveling 63MPH in a posted 50MPH zone. Deputy Ross observed the defendant operating and to be the sole occupant the vehicle and detected signs of impairment. Affiant responded to the scene, detected an odor of an alcoholic beverage emanating from her breath, her eyes were bloodshot and glassy, her speech was slurred, and she was unsteady on her feet. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant refused to provide a lawful breath sample to determine her breath alcohol content (BrAC). Affiant read Implied Consent to the defendant, she understood and replied "No." The defendant was identified via FL DL. The defendant was given a DUI citation 3941XGA which reflects the DUI charge. The defendant also received Uniform Traffic Citation AEIKYZE for Speeding.
