The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
The defendant was operating a Hyundai (FL# GDER11) and failed to yield at a marked stop sign intersection causing an accident (TPD#21-194276) causing approximately \$3,000 in damage. The witness (and other party involved in the crash) indicated that he could smell alcohol. The defendant had several indicators of impairment. At the conclusion of the crash investigation, the defendant was advised that the civil investigation was complete and a criminal investigation for DUI was starting and she agreed to completed SFSE. At the conclusion of SFSE and showing several signs of impairment the defendant was placed under arrest and transported to CBT. The defendant was read implied consent and refused to provide a breath sample.

A DHSMV response showed that the defendant has two active suspensions one from 04/29/2020 (FR suspension) and a second one on 10/22/2020 (Driving with unlawful BAL .08% or above).

The defendant is being charged with DUI - property damage for causing the crash and driving with a suspended license in violation of Florida State Statute. The defendant was positively identified by the Affiant through her DHSMV photo.
