Fajardo Batista advised an argument began with Corsaw III while she was laying down in bed. Fajardo Batista advised she told Corsaw III she wanted to break up and Corsaw III began stating he was going to share her nude photos on the internet. Fajardo Batista advised during the time Corsaw III grabbed her by the arms pushing her into the bed. Fajardo Batista further advised Corsaw III used his open hand to grab her face, pinning her down to the bed. Fajardo Batista advised she then pushed Corsaw III and kicked him to push him away from her.

Contact was made with Corsaw III who advised he was laying down with Fajardo Batista. Corsaw III advised Fajardo Batista was attempting to become intimate while he was having a conversation with her about getting a job. Corsaw III advised Fajardo Batista became extremely upset and began wrestling him in an attempt to fight him. Corsaw III advised Fajardo Batista then bit him in the back leaving visible bite marks. Corsaw III advised Fajardo Batista kicked him in the face.

Fajardo Batista had no visible marks.

Corsaw III had a visible bite mark on his back.

Due to conflicting account of events, Officer was unable to determine primary aggressor.
