ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE THE VICTIM, HIS GIRLFRIEND AND CO-HABITANT, AGAINST THE WILL OF THE VICTIM, TO-WIT: HIT THE VICTIM ON HIS RIGHT ARM WITH HER CELL PHONE.

THE VICTIM AND SUSPECT WERE LYING IN BED TOGETHER WITH THEIR THREE YEAR OLD DAUGHTER BETWEEN THEM. THEY WERE VERBALLY ARGUING AND INSULTING EACH OTHER WHEN THE SUSPECT SUPPOSEDLY BEGAN HITTING THE VICTIM ON HIS RIGHT ARM WITH HER CELL PHONE. YOUR AFFIANT ALONG WITH LEALMAN F.D. PARAMEDICS SAW NO INJURIES. HOWEVER, THE VICTIM WENT TO NORTHSIDE E.R. AND OBTAINED PAPERWORK THAT HE WAS TREATED FOR A CONTUSION ON HIS RIGHT ARM AND SOME REDNESS WAS SEEN ON HIS RIGHT ARM. THE SUSPECT DENIES COMMITTING THE BATTERY. DEPUTIES HAVE RESPONDED TO THIS SAME RESIDENCE ON AT LEAST THREE OTHER OCCASIONS FOR SIMILAR DOMESTIC COMPLAINTS.

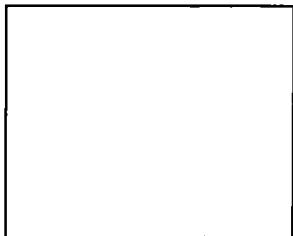
