PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)
On September 11, 2021 I responded to Central Blvd and Indian Creek Parkway in reference to a single vehicle that crashed into a tree. Upon my arrival there was a back Porsche bearing FL tag NSUK39 that had made front end collision with a royal palm tree. The driver, W/M Ankit Mehta (05/16/1977) was advising officers that he was not driving the vehicle when it crashed. His story was inconstant with first responding Officer, R. Nobel of the Jupiter Police Department, who stated that he saw Mehta exit the vehicle from the driver's door. Mehta had seatbelt marks on him consistent with the driver's side seatbelt. Upon asking Mehta what happened, he stated that someone else was driving. Upon further questioning, Mehta admitted to driving. Mehta was making comments that he was out drinking. Upon changing hats and reading Mehta his Maranda Warnings he advised that he was driving and it was an accident. He said the turn was too sharp. Mehta refused roadside tests and refused BAT at 2331 hours. Mehta was found in violation of FSS 316.193(1)(A) DUI Normal Faculties Impaired and placed under arrest. A search of the vehicle by Ofc R. Nobel found a bottle of jack Daniels in the backseat.

OBSERVATION OF DRIVER:

Mehta appeared to be sweating and had glossy eyes. His breath smelt of alcohol. He was making statements that did not add up to the investigation in order to conceal the fact he was driving. Mehta would not comprehend simple commands in English such as, stand back please, and you are too close back up.

DRIVER'S STATEMENTS:

Mehta stated that someone else was driving until he talked himself into the truth.
Mehta stated that he was out drinking. He did not specify how much (bottle of jack Daniels found in the back seat)
Mehta kept asking if there was any way we could not arrest him for DUI.
Mehta kept apologizing saying it was a stupid accident.

ODORS:

Odor of alcohol emitting from his breath.
