On the above date and time I Tpr D Kates-Paulus (ID 704) was in the area of Tangerine blvd and Coconut blvd traveling west in a fully marked FHP patrol unit (FHP0412). As myself and the vehicle in front of me pulled to the 4 way stop at the intersection of Tangerine Blvd and Coconut blvd a silver SUV style vehicle traveling at an excessive rate speed failed to come to a stop prior to the posted stop sign. The vehicle abruptly slowed entering into the middle of the intersection. The vehicle in front of me had started to pull away when they observed the silver SUV coming and stopped to avoid a collision. The silver SUV bearing Florida registration WY83F, then made an abrupt right turn heading east on tangerine at a high rate of speed. I made a u-turn in the intersection never loosing site of the vehicle and executed a vehicle stop on that vehicle bearing FI Registration WY83F. As I approached the drivers window an odor of an alcoholic beverage was coming from the drivers breath and person. The driver was lethargic and slow to answer me about the incident. While attempting to speak to the driver she was asked for her drivers license to which she stated she did have. The driver fumbled through her vehicle and wallet checking the same spots multiple times then stopping the search. The driver was identified through NCIC/FCIC as

Deputy pulled up behind me. PBSO had been receiving multiple calls on a vehicle that matched the description of the vehicle I had stopped. PBSO did verify that the calls they were receiving was of the vehicle I had stopped that they had been looking for in the area. The traffic stop was handed over to PBSO after the driving was issued citations for the traffic stop. This incident did occur within the limits of Palm Beach County.


