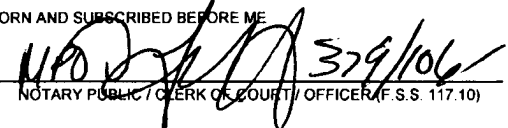
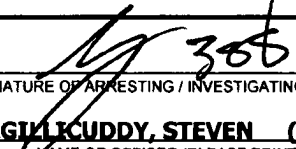

On the 23 day of April, 2022 at 08:06 (Specifically include facts constituting cause for arrest.) On 4/23/2022, at approximately 0806 hrs, I was conducting selective traffic enforcement in the area of Military Trail and Marquette Drive, within the Town of Jupiter, Florida. My patrol vehicle was oriented southbound in the median and I was monitoring northbound traffic. I observed a white Ford truck (KTQ-Y18) northbound on Military. I estimated the speed of the vehicle to be 65 MPH (45 MPH ZONE). I activated my calibrated dash mounted radar, heard a steady audio Doppler tone consistent with that speed, and observed a true speed readout of 66 MPH. I conducted a traffic stop on the vehicle in the area of Toney Penna Drive, just east of Military Trail, and made contact with the driver, Anna Spicer. As soon as I approached Spicer's window, I detected a strong odor of fresh cannabis emitting from the interior of the vehicle. Spicer apologized for going so fast and said she had just gotten a ticket for the same thing. I asked her if there was any marijuana in the vehicle and she said yes. She said that she had not yet gotten a medical marijuana card. I asked her where it was and she advised me it was in the center console by pointing to it. I returned to my vehicle, conducted a records check on Spicer and asked for backup. Once my backup arrived I re-approached Spicer. She confirmed for me that it was marijuana in the vehicle and not cbd or hemp. I asked her if I was going to find anything else in the car and she asked, "are you going to search my car?". I advised her that I was and she stated that she also had a bong in the vehicle. I had her exit the car and I conducted a vehicle search. Inside of the center console I located a plastic baggie containing approximately 14 grams of cannabis. I also located a red grinder containing cannabis residue. In the passenger compartment area I located a plastic cannabis dispensary container containing an additional approximately 12 grams of cannabis. Officer Yochum arrived on scene and

provided me with a digital scale and I confirmed that the total weight of the cannabis (without the plastic packaging) was approximately 26 grams. Based on my investigation, I have probable cause to believe that Spicer was in unlawful possession of a felony amount of cannabis, to wit, over 20 grams, without a valid prescription pursuant to a lawful medical order, contrary to F.S.S. 893.13(6A). Spicer was in unlawful possession of drug paraphernalia, to wit, a red cannabis grinder and glass water bong, with the intent to use the aforementioned items in the ingestion of cannabis, contrary to F.S.S. 893.147. I transported Spicer to JPD for paperwork. I then booked her into the Palm Beach County jail on the above offenses. I cited her for speeding and gave a written warning for failure to exhibit a driver's license. BWC.
