The following incident occurred in the City of Delray Beach, Palm Beach County, Florida. On March 14th, 2022, Delray Beach Police received a package containing an initial investigation of the distribution of child pornography from Manchester NH Police Department conducted by Det. Michael Valenti (Case #21-013336). According to the Manchester police report, on September 15, 2021, the victim, [REDACTED] responded to the Manchester Police Department in reference to nude photographs/video of her being posted on the Twitter account (@snipmycory). [REDACTED] stated that the photographs were taken two years prior when she was 15 years old. It should be noted that at the time of the initial complaint, [REDACTED] was 17 years of age, making her a juvenile victim. On October 11, 2021, Det. Valenti had applied for a search warrant for Twitter which returned the following information for Twitter Account (@snipmycory): Email: bigbqlls234@gmail.com IP Address: 174.193.5.207 On October 20, 2021, Det. Valenti received the requested account information from Twitter. According to Det. Valenti, he reviewed the following data: one MP4 file, which was a 12 second clip of a rotating 3 second video of our juvenile victim showing her vagina, a JPEG file of our juvenile victim with her breasts exposed, and an additional JPEG file showing our juvenile victim with her breasts exposed along with the caption "[REDACTED] cunnning she plays with her minge behind hubby Richard cooper sending videos like this one to married men real classy I think this ones worst then his baby momma Susie because she's so inccocent isn't she `DEVIL EMOJI` stretched minge `COWBOY SMILING EMOJI` ". The video and photo were consistent with the images Det. Valenti viewed on the original bodycam footage from Manchester PD.

PROBABLE CAUSE STATEMENT

On October 20, 2021, Det Valenti applied for a Google search warrant in reference to the email address, bigbqls234@gmail.com. On November 8, 2021, Det. Valenti received the requested information from Google. There was nothing of evidentiary value attached to the account.

On November 8, 2021, Det. Valenti applied for a search warrant in reference to the IP Address associated with the suspect Twitter account: 2600:1004:b092:fb46:c4bf:f72d:9898:b6da. The warrant was sent to Verizon on November 9, 2021. On March 8, 2022, Det. Valenti received the requested information from Verizon. The IP address for the Terms of Service IP came back to the following:

Jennie Marie Stanley Miller, DOB: 10/15/78
306 SE 1ST Ave, Delray Beach, FL

In his report, Det. Valenti stated the following, "In looking up potential contacts, the following is likely to be the suspect: Annabelle Stanley DOB 10/25/99, 306 SE 1ST Ave. Delray Beach, FL."

On March 17, 2022, a consensual encounter was made with Annabelle Stanley at her residence, 306 SE 1st Ave. During my encounter with Stanley she initially denied any involvement in the posting of the photo an images, but did indicate that she had knowledge twitter account, @snipmycory. It should be noted that the entire encounter was captured on BWC. After speaking with Stanley, I took a sworn statement from Stanley's sister, Savannah Miller. Miller was questioned about the photo/video as well as the twitter account, @snipmycory. Miller stated that her sister, Stanley, had showed her the account on her phone and admitted to being the one who had involvement in posting image and video of [REDACTED] A. Stanley informed me that she and [REDACTED]

After speaking with Miller, I again spoke with Stanley who eventually recanted her initial statement and admitted that the photo and video had been posted from her phone. Stanley admitted that the phone in her possession was the phone that was used. The phone was seized as evidence so that no evidence could be destroyed and/or altered. It should be noted that Stanley admitted that while I was there, she attempted to delete the image and video that was posted on the account @snipmycory. She stated that the image and video was in her recently deleted file on her phone. Stanley signed a consent to search form and provided me with the passcode to her phone. Prior to leaving the residence I provided Stanley with a case card what contained my direct phone number and email address.

On the same date, the phone was delivered to Maxx-Anne Miller, the Digital Forensic

In the recently deleted file of her images, I located the still image and video that was posted to the twitter account, @snipmycory. According to the data on Stanley's phone, the images were saved on August 20, 2021. I was unable to locate the twitter account, @snipmycory, or the email address, bigbqls234@gmail.com. Based on the above facts, probable cause exists to charge the defendant, Annabelle Stanley, with 2 counts of POSSESS, CONTROL OR INTENTIONALLY VIEW A SEXUAL PERFORMANCE BY A CHILD, pursuant to FSS 827.071 (4), and 2 counts of TRANSMITTING CHILD PORNOGRAPHY, pursuant to FSS 847.0137(2).
