Ofc Witt 492, stated he was in the area of N Military Trail, just South of Northlake Blvd, PBG, FL, when he observed a vehicle being driven recklessly. Ofc Witt said the vehicle appeared to be traveling North bound on N Military Trail, in-excess of 80 MPH in a posted 45 MPH zone. Ofc Witt said the vehicle then made a left turn to go West bound on Northlake Blvd and struck a raised concrete curb, as well as break traction and drift sideways. The vehicle then accelerated through a residential neighborhood before he was able to stop the vehicle in the 9100 block of East Highland Pines Dr. Ofc Witt identified the driver of the vehicle, via Florida Driver License photo, Anthony Mattys. This Officer made contact with Mattys when he was already outside of the vehicle.
