STATEMENT	While conducting my initial investigation, the defendants advised they received bad service and only wanted to pay their bill and leave the restaurant. Both defendants denied causing a disturbance and striking anyone. Both defendants initially stated that they were the ones who were assaulted/battered by the staff and demanded that we check the surveillance footage. It should be noted that while speaking with the defendants, I could smell an odor of an unknown alcoholic beverage emanating from their body and breath. I also saw that both had red glassy eyes and slurred speech. Finally, I reviewed the surveillance footage, which corroborated that Serrano shoved Tucciarone, then also struck Cavazos. Additionally, it was clearly observed that Genovese had been aggressively attempting to get to both Tucciarone and Cavazos as they were cornered at the bar. An unknown male in a white shirt was scene holding Genovese back, while										
PROBABLE CAUSE STAT	Genovese is seen lifting his arms up and trying to advance towards the two female victims. It was also corroborated that no staff members attacked the defendants and that both defendants did not act in self-defense. Based on the above facts, Maria Serrano did commit two (2) counts of Battery F.S.S. 784.03(1A1), by knowingly and willfully touching/striking Tucciarone and Cavazos, by shoving both of them against the bar, without their consent, pursuant to FSS 784.03(1)(a)(1)
