The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a gray Jeep Wrangler SUV bearing FL tag NXAC28. The vehicle was observed weaving in its lane as it travelled eastbound on Swann Av approaching Howard Av S. The vehicle continued infrequently weaving in its lane northbound on Howard Av S. The vehicle made a sharp turn westbound onto Kennedy Bv W, and continued to weave, at times with the drivers side tires driving along the lane dividing line and splitting the westbound lanes. I stopped the vehicle to check on the welfare of the driver and upon contact with the defendant observed that his eyes were glassy and droopy. His speech was very slow and slurred and I detected the odor of an alcoholic beverage emanating from his breath. I observed an open can of "White Claw" hard seltzer in the center console. The defendant was unsteady on his feet and admitted to drinking. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.

The defendant provided breath samples of .229/ .239.

The defendant was ID'ed via FL DL.
