The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 02 day of JUNE, 2020

at approximately 1:17 AM, at 1301 1ST AVE NORTH, in Pinellas County did:

THE DEFENDANT DID THEN AND THERE DID ORGANIZE 3 DAYS OF POLICE PROTESTS AT ST PETERSBURG'S CITY HALL AND POLICE HEADQUARTERS VIA FACEBOOK. DURING THE MULTIPLE DAYS OF PROTESTS WHICH GREW TO OVER 200 PEOPLE MULTIPLES TIMES, OFFICERS WERE STRUCK WITH THROWN OBJECTS, A POLICE CRUISER WINDOW WAS SMASHED, AND ROCKS AND BOTTLES WERE THROWN AT THE POLICE STATION WHILE CHANTING PHRASES SUCH AS "HEY HEY HO HO RACIST COPS HAVE GOT TO GO" "FUCK THE POLICE" AND "KILL THE KILLER COPS"

ONE THE SECOND NIGHT OF PROTESTS AN UNLAWFUL ASSEMBLY WAS DECLARED BY SPPD AND THE CROWN WAS DISPERSED. SHORTLY AFTER THE DEFENDANT ATTEMPTED TO AGAIN ORGANIZE PROTESTERS IN THE STREETS AND MARCH BACK TO THE STATION DISOBEYING THE UNLAWFUL ASSEMBLY. THE DEFENDANT WENT ON TO PROMOTE THE SAME TYPE OF BEHAVIOR TO TAKE PLACE THE NEXT DAY STARTING AT 2 PM.

ON THE THIRD NIGHT OF THE PROTEST A VEHICLE INVOLVED WAS STOPPED AND THREE INDIVIDUALS WERE FOUND TO BE IN THE POSSESSION OF A CONTAINER OF GASOLINE, ASSORTED BRICKS, AND MATERIALS USED TO ASSEMBLE CRUDE INCENDIARY DEVICES COMMONLY KNOWN AS A "MOLOTOV COCKTAIL". SHORTLY AFTER THE TRAFFIC STOP PROTESTERS ATTEMPTED TO REMOVE BARRICADES WHICH WERE SET IN PLACE IN FRONT OF THE STATION AND BEGAN DRIVING VEHICLES THE WRONG DIRECTION ON A ONE WAY ROAD CAUSING A PUBLIC SAFETY CONCERN AND ULTIMATELY ANOTHER UNLAWFUL ASSEMBLY WAS DECLARED. THE DEFENDANT WAS TAKEN INTO CUSTODY SOUTH OF THE POLICE HEADQUARTERS AND FOUND TO BE IN POSSESSION OF A BACKPACK CONTAINING BALLOONS AND SHAVING CREAM WHICH ARE COMMONLY USED IN PROTESTS TO HINDER THE POLICE FROM MAKING ARRESTS, AS WELL AS USED AS PROJECTILES.

THE DEFENDANT ADMITTED POST MIRANDA TO ORGANIZING THE EVENTS AND THE USE OF THE ITEMS LOCATED IN HIS BACKPACK HOWEVER CLAIMED THAT HE WANTED TO KEEP IT PEACEFUL.

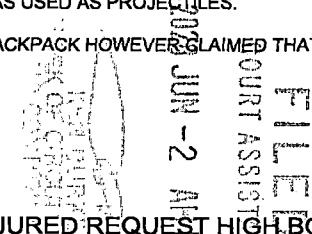

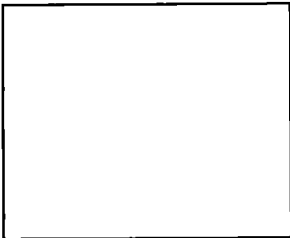
