The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a 2015 Gray Hyundai four door bearing a Florida license plate of DGVK96. He was traveling north on N Armenia Ave at W Crest St and was driving without headlights and taillights on. A traffic stop was conducted at Hillsborough and Armenia and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, slurred speech, slow and sluggish reactions, an odor of an alcoholic beverage, and an admission to consuming alcohol (stated he had two Truleys). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the Implied Consent Warning. In addition, the defendant had four children in his vehicle (ages 10, 4, 12, and 10).

The defendant was identified by his FL DL.
