The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 5/31/2020 at approximately 0326 hours, I observed a white 4 door Honda Accord bearing FL tag GBJV28 (VIN: 1HGCR3F80FA024367) traveling northbound on Dale Mabry Hw near Waters Av. The Honda was crossing into other lanes of travel and speeding (72 in 45 MPH zone). I conducted a traffic stop and made contact with the driver/defendant, I immediately noted the strong odor of an alcoholic beverage on his breath, bloodshot watery eyes and slurring his speech. I asked several times if the defendant wished to complete the SFSE's. After completing the HGN exercise the defendant exclaimed he was unable to do the remaining exercises. Once at CBT, the defendant provided 2 lawfully requested breath samples of 0.174/0.180%BAC after a proper 20 minute observation period. I issued the defendant DUI citation AA2S2SE for DUI over 0.150. The defendant identified himself via United States Passport Card (#C16157534).
