Probable Cause Affidavit

Before me this date personally appeared O SHIELDS, CHRISTINA (9082) who being first duly sworn deposes and says that on 2 day of May, (year) 2017 at 1 SEMINOLE WAY, HOLLYWOOD, FL 33314 the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows advised that her boyfriend and her were involved in a verbal argument because he wanted to stay and gamble and she wanted to leave. She stated at no time was there a physical altercation.

Hard Rock Hotel and Casino President Auggie Cipollini approached me after speaking with Fernandez and advised that he observed the female striking the male in the valet (pick up area). He stated she punched him with a close fist in the upper chest area and he began clapping. At this time, contact was made with Fernandez a second time and I asked her if she recalled striking her boyfriend of 6 months of which they reside together. She stated no, there was no physical altercation.

Contact was made with the surveillance room where the video of the incident revealed white female Arianna Fernandez willfully striking her boyfriend one time in the upper chest area with a closed fist, he did not strike back as he continued to walk away. At this time, contact was made with Fernandez and I placed her under arrest for domestic battery.
