The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 02/26/2020, at approximately 0357 hours, the defendant was driving a blue Lexus ES 300, bearing Florida tag EEVN28, with an assigned VIN of JTHBF30G025019335, northbound on North Dale Mabry Hwy with both the driver's side tires flat and riding on the rims. Deputy A. Borrero (ABN 257069) observed this vehicle and conducted a traffic stop at the intersection of North Dale Mabry Hwy and Lake Carroll Way. Upon contact with the defendant, she had a hard time finding her paperwork (fumbling fingers), bloodshot glassy eyes and the distinct odor of an alcoholic beverage emitting from her breath as she spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which she agreed. During the exercises, the defendant showed signs of impairment and was placed under arrest for DUI. The defendant then provided a lawful sample of her breath resulting in a BAC of .120/.121. The defendant was identified via her DAVID photograph.
