The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a black 2017 Honda Civic (FL TAG #LTQZ33) westbound on Twiggs St E, when she ran the red light at Florida Av N and crashed into a black 2014 Ford Explorer (FL TAG #2108QR) as it was driving northbound. The crash caused approximately \$20,000 in damages and there were no injuries. The defendant was positively identified by the eyewitness (ANTHONY J. CHOUEIFATI) to be the driver of the black Honda. During the traffic crash investigation, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot, blank/dazed stare, droopy eyelids, slurred speech, poor balance, she was confused/disoriented, moved with slow/deliberate movements, admitted to drinking alcohol (a margarita) prior to driving and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she refused to provide a breath sample and has a prior refusal to submit suspension on 05/01/2010.
