The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
 On the above dated and time at the above listed location, I observed a red Ford 150 bearing Florida tag: EMJG56, running a red light. I conducted a traffic stop on the listed vehicle. Upon making contact with the defendant; I detected indicators of impairment. I requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to perform. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. The defendant agreed to provide two lawful breath samples to determine his breath alcohol content (BrAC). After a proper 20 minute observation period was conducted, the defendant provided two lawful samples of his breath. First BrAC sample (.180); Second BrAC sample (.174). The defendant received a DUI citation #AAZ60ME, which reflects the DUI charge. The defendant was identified via his Florida Driver's License.
