The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 5-20-2021, at approximately 1914 hours, located at 7420 Paradiso Drive, the defendant and the witness (15 year-old son) were involved in a verbal argument about pictures inside a frame. The victim approached the defendant and instructed the witness to go to his room. The defendant and victim began a verbal argument which turned physical when the two struggled over the picture frame. The defendant then unlawfully and intentionally struck the victim against his will, with a right hand (unknown whether opened or closed fist) on the left upper chest. The witness was just outside the bathroom where the incident occurred and only heard the event. The defendant and victim live together, are married (15 years), and have a child in common. The victim and witness positively identified the defendant as the person who committed the offense. The defendant was positively identified using her Ohio Driver's License.
