


Officer Anderson then met with _____ inside the apartment where she was sitting at the kitchen table. and she went to her bedroom. According to Officer Anderson, during the time [REDACTED] was explaining to him what happened she started crying and appeared to be afraid to express herself. Officer Anderson asked [REDACTED] if she was afraid of Armando and she said "Yes".

Officer Anderson documented all the visible injuries on [REDACTED] as described on his report.

After Officer Anderson completed his initial investigation at the above residence, he proceeded to the home of [REDACTED] and Armando Bravo located at 692 Springdale Blvd. Palm Springs, Florida.

Upon arrival Officer Anderson met with [REDACTED] and Armando outside their home in which he informed them that he was conducting a child abuse investigation. At the time Armando appeared to be agitated with Officer Anderson. Officer Anderson asked Armando how [REDACTED] got the bruising and markings on her body and he stated that he grabbed her by her dress and forced her into the door. Armando stated he did not "slam" her towards the door in an aggressive manner. Armando said, "Yeah I lost my shit but I'm tired of her being disrespectful". Officer Anderson asked Armando about slapping [REDACTED] in the face open handed and he remained silent. Armando admitted to shoving [REDACTED] towards the door several times and said she possibly could have hit the back of her head on the door. Armando stated the reason for [REDACTED] marking and bruises is because they were wrestling earlier that day. Armando became defensive the more Officer Anderson asked about the incident. [REDACTED] then told Officer Anderson that sometimes she slaps [REDACTED] in the face as well. Following Officer Anderson investigation, he later contacted DCF to report his findings of the investigation.

On August 18, 2020, I received the above case in the Criminal Investigations Unit to further investigate this case.

On August 19, 2020, I met with DCF/CPI Diaz in reference to the above case and I was provided with other associated cases involving DCF and the Bravo family.

On August 26, 2020, I responded to CPT for the Forensic Interview and Medical Evaluation of [REDACTED]

On September 21, 2020, I reviewed the CPT Forensic Interview and Medical Evaluation Report with the following findings.


During the Forensic Interview [REDACTED] remained consistent with how the incident happened involving Armando. [REDACTED] stated that once she completed the pushups. She went upstairs and went to the bathroom soon after [REDACTED] came upstairs and offered her ice. [REDACTED] stated she told [REDACTED] she was okay. [REDACTED] stated that she told [REDACTED] that she did not want her father to find out what happened to her. According to [REDACTED] told her play the "I don't know card." The next day she woke up and saw all the bruises on her body were worse than the day before. [REDACTED] stated that she told her sister [REDACTED] not to tell their father when they got home. According to [REDACTED] when they arrived at their fathers' home, her father noticed right away the mark on her neck. He asked her about it and she told him she did not know. Her sister [REDACTED] blurted out that she knew what happened. She told her father "Armando" did it.

CPT Medical Assessment:

Positive findings for physical abuse: There are allegations of physical abuse towards this 11 year-old child, [REDACTED] by [REDACTED] and alleged perpetrator (AP) Armando Bravo, resulting in him grabbing her by her dress, pushing her against the door and slamming her head against the door several times causing her to have bruising and marks to her head, neck, arms, chest and back.


CPT reviewed the photos taken by DCF on August 18, 2020 which reveals markings: A dark purple area of ecchymosis, which appears to be in the shape of a handprint (approx.: 5x3cm) to the anterior left upper arm with faint red petechiae, a circular dark purple bruise to the lateral right shoulder region, two superficial marks to posterior upper back (approx.: 3x1cm) one bluish area (5x5cm) with red petechiae and superficial scratches to anterior chest wall and neck, a crescent shaped mark resembling a finger (2.5x2cm) to lateral neck, and a red mark (0.5cm) to crown of head near hairline.




