The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was driving a 2013 Chevy SUV bearing a New York license plate of JGB4823. He was traveling leaving a club on Adamo Dr after an altercation that Tampa Police investigated. The defendant was observed getting in his vehicle and driving away after having contact with the Tampa Police Officers who observed his extreme intoxication. A traffic stop was made and upon making contact with the defendant he displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, and an unsteady walk. The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test despite acknowledgment of the implied consent warning.

The defendant was identified by his New York DL.
