 The defendant, who was identified by Florida driver's license, was stopped for speeding. Upon making contact with him I observed that his eyes were watery and bloodshot, there was a strong odor of an alcoholic beverage emitting from his breath and there was an alcoholic beverage in a plastic cup in the center console and an open bottle of Whiskey in plain view on the back seat.
