Probable Cause

On 8/21/21, at approximately 12:23 am, I was dispatched to the southbound ramp of Interstate 95 from 45th Street. When I arrived on scene around 12:36 am, I observed a white Hyundai Veloster parked stationary in the right shoulder of the

ramp in front of 3 West Palm Beach police vehicles. I was then approached by officer K. Harrell who then proceeded to explain why he made a traffic stop of the vehicle in question.

After officer Harrell completed explaining the probable cause for pulling the vehicle over, he then told me that the driver was still sitting in the vehicle. I then walked over to the driver side door of the Hyundai Veloster and noticed a white female sitting behind the wheel of the vehicle. Upon speaking to the driver (later identified as Ashley Bickle from DAVID as she did not have her Driver's License present) I noticed that her eyes were red and bloodshot. I also could detect the moderate smell of an alcoholic beverage emanating from Ms. Bickle, even though I was wearing my Covid KN95 fabric mask.

While one of the West Palm Beach police officers kept an eye on the passenger, I then walked Ms. Bickle to the front of my in patrol car (where my in-car camera was pointing). This was where I conducted my sobriety interview with Ms. Bickle. The below summary is an abbreviated version of the Standard Field Sobriety Exercises that was performed. Video and audio footage should give a more detailed representation of what actually occurred.

Horizontal Gaze Nystagmus (Using a Zebra F-301 ballpoint pen with silver tip)

Checked for resting Nystagmus which was not observed in either eye.
Checked for pupil size and equal tracking. Both pupils were dilated, but still tracked equally.

When tracking, I noticed a lack of smooth pursuit in both eyes. Ms. Bickle could not keep her head still. She kept moving her head slightly when following the tip of the pen.

I observed Nystagmus at approximately 30 degrees in both eyes.
I also observed sustained Nystagmus at maximum deviation in both eyes.

Was not able to keep her balance while in starting position.
 Could not stay in the starting position while I was explaining the exercise to Ms. Bickle.
 Was not able to place her right foot in front of left foot, touching heel to toe at starting position without fighting to keep her balance.
 Started exercise even before I had a chance to tell Ms. Bickle to begin.
 Walked straight ahead without counting out loud. Did not walk 9 steps. Other than for the first step, did not touch heel to toe the rest of the way forward.
 Started dancing on the walk back.
 Very unsteady on her feet.

One Leg Stand

Already unsteady while standing in starting position
 Could not count as instructed (gave her a choice of counting one thousand ONE, one thousand TWO....or ONE, one thousand, TWO, one thousand. I finally let her count any way she wanted).
 Could not follow what I trying to get her to do.
 Placed her foot down only after counting to 10 (and I gave her two attempts)

Based upon the performance of the above exercises, her inability to remember my instructions, and her confusion throughout my investigation, I determined that there was probable cause to arrest Ms. Bickle for Driving Under the Influence. Ms. Bickle was then placed under arrest at 12:52 am, handcuffed and placed in the back of my patrol car. Ms. Bickle was then transported to the Palm Beach County Breath Alcohol Testing (BAT) facility. At the BAT, after a 20 minute mandatory observation period, Ms. Bickle was then asked to provide 2 (or more) breath test samples to test for the alcoholic content in her system. Ms. Bickle was able to provide 2 samples at 0.248 and 0.268. Ms. Bickle was then issued a citation for DUI and booked into the Palm Beach County jail. Ms. Bickle's vehicle was towed by Kauff's Towing to their yard.

| <p>On August 21st 2021 approx. 0015 hours while traveling in my marked patrol West Palm Beach Police Unit, I was driving eastbound on 45th Street approaching the southbound on ramp of I-95 intersection. As I was about to enter the on ramp, I witnessed a white in color Hyundai Veloster (bearing Florida plate # KAS-234) traveling in the far inside lane of 45th Street (Southbound) suddenly turning across all eastbound lanes in front of other vehicles and coming close to hit my vehicle as the vehicle attempted to enter onto the southbound ramp. The vehicle continued forward after I had it suddenly brake to avoid a crash.</p> <p>I then conducted a traffic stop on said vehicle and approached the driver's side of the vehicle to make contact with the driver. Upon contact with the driver, I was able to smell a very strong odor of alcohol coming from the interior of the vehicle. The driver was asked to produce her drivers license and vehicle information. The driver was speaking in a slurred speech, eyes were glassed and watery. I then requested dispatch to notify TWP for assistance.</p> <p>While waiting for TWP, the driver & sole passenger were interviewed. B.C. recorded admitting drinking too much this evening & that she should have not decided to drink tonight. TWP later arrived to assist on the D.W.I. investigation.</p> | | | | |
